KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, as Chief Executive Officer and President, and Secretary of THREE SPRINGS, INC., a corporation organized and existing under the laws of the State of Alabama (the "Corporation"), hereby certify that, in accordance with Sections 10-2B-10.01, 10-2B-10.03, and 10-2B-10.07 of the Alabama Business Corporation Act ("ABCA"), the Articles of Incorporation of the Corporation (the "Articles") were amended by unanimous written consent executed by all the shareholders and directors of the Corporation, and state as follows:

FIRST: That the present name of the Corporation is THREE SPRINGS, INC.

SECOND: That the date of filing of the original Articles with the Judge of Probate of Madison County, Alabama, was January 7, 1985;

THIRD: The Amendment was approved by a vote of the Shareholders on December 15, 2009;
