In response to the above referenced letter, attached is an affidavit dated April 21, 1999, and executed by the undersigned setting forth the facts regarding the contacts of Allianz Risk Consultants, Inc. ("ARC") with the State of Florida from 1995 through 1998.

Based on such facts, we believe that ARC's contacts from 1995 through 1998 with the State of Florida do not constitute transacting business within the meaning of s.607.1501, F.S. Specifically, we believe that ARC's contacts fall within the following exceptions of s.607.1501, F.S.:

Subsection (2)

- Paragraph (e): All activities are conducted by independent contractors.

 Note It is our belief that the arms-length contractual arrangement between ARC and Allianz Insurance Company fall within the meaning of this paragraph.
- Paragraph (f): All work orders are obtained through agents and require acceptance outside Florida before they become contracts.

Notwithstanding the fact that we have chosen to seek authority for ARC to transact business in 1999, we believe that ARC was not required to seek such authority in the prior years.

Accordingly, we request that the demand for annual report fees and penalties for the prior years be withdrawn.

The undersigned, Paul D. Kaduk, being of legal age and duly sworn, states as follows:

- 1. I am Secretary and Treasurer of Allianz Risk Consultants, Inc. ("ARC") and I have first-hand knowledge of the facts set forth herein.
- 2. ARC was incorporated on January 4, 1995, in the state of California.
- 3. ARC's sole business activity is to conduct risk analysis on behalf of insurance companies for purpose of underwriting insurance policies.
- 4. ARC did not obtain a certificate of authority to transact business from the Florida Department of State in 1995, 1996, 1997 and 1998.
- 5. ARC had clients located in the state of Florida in 1995, 1996, 1997, and 1998.
- 6. ARC does not have employees. All contacts and activities with clients in the State of Florida in 1995 through 1998 were made by contractors.
- 7. With respect to the services provided, ARC contracts, on an arms-length basis, with its parent company Allianz Insurance Company ("AIC"), which is authorized to transact business in Florida and is subject to tax in the State. Under the contract, all contacts and activities with Florida clients are performed by employees of AIC.
- 8. ARC does not actively solicit business within Florida and that all revenues derived from Florida-based clients are generated from referrals.
- 9. All of ARC's work orders are obtained through agents and require acceptance outside Florida before they become contracts.


