
Dear Ms. Lunt:





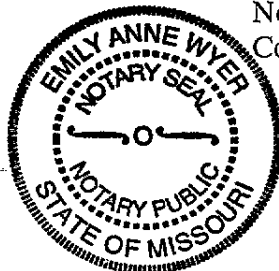
