STATEMENT OF PURPOSE

Dana-Farber Cancer Institute

Brigham and Women's Hospital

Massachusetts General Hospital Dana-Farber/Partners Cancer Care, Inc. (the "Corporation") is organized and shall be operated exclusively for the benefit of The Brigham and Women's Hospital, Inc. ("BWH"), Dana-Farber Cancer Institute, Inc. ("Dana-Farber") and the General Hospital Corporation ("MGH") (collectively referred to as the "Hospitals"), and in furtherance thereof the Corporation shall coordinate the delivery of inpatient and outpatient adult oncology services at the Hospitals, and shall establish common guidelines and protocols for such oncology services. In addition, the Corporation shall assist the Hospitals in the coordination of their efforts to meet the medical needs of the patients located within the Hospitals' service areas and participate in their educational programs in oncology, facilitate more effective clinical research by the Hospitals, and otherwise carry out the Hospitals' charitable purposes.


