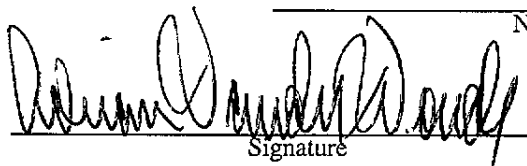

Pursuant to the provisions of Section 10-2B-10.03 of the Code of Alabama, the undersigned Corporation created and existing under the laws of the State of Alabama hereby adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the Corporation is Alabama Clarklift, Inc.

SECOND: The following Amendment to the Articles of Incorporation was adopted by the Board of Directors and the Shareholders of the corporation on the 7th day of August, 2000, in the manner prescribed by the Alabama Business Corporation Act:

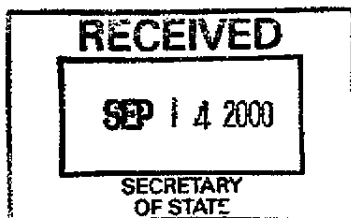
RESOLVED THAT: The name of the Corporation shall be changed from Alabama Clarklift, Inc. to **"Total Handling Equipment Company, Inc."**

THIRD: Section 1.1 of Article I shall be amended to read as follows:

"1.1 The name of the Corporation shall be Total Handling Equipment Company, Inc."

FOURTH: The number of shares of the Corporation outstanding at the time of such adoption was 1,000 shares of common capital stock; the number of shares entitled to vote thereon was 1,000; and all of the said shares were voted in favor of this Amendment, which vote was sufficient to approve of this Amendment.
