Thank you for your letter of May 10 regarding Cleat Marine, Inc. (ref. number W99000010811). Had I realized that "registering of a foreign corporation" was necessary, I would have done so immediately. I was not aware of the requirement until April, when I applied for a dealers license, at which point the state representative at the Department of Revenue told me I needed to register the corporation.

Up until that time the corporation had been used to service my banking and taxes as a self-employed yacht broker (working at Bollman Yachts in Ft. Lauderdale) and not to conduct business as a full fledged corporate entity.

Although it has often been said that ignorance of the law is no excuse, I am hoping that your office will take into account these circumstances and my good intentions, and will consider them as ameliorating circumstances in assessing a less severe penalty fee.
