We request waiver of any late filing for the following reasons:

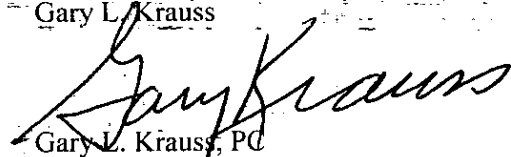
- 1) We never received anything advising us about an annual report.
