We are responding on behalf of the above named corporation to the letter dated March 19, 1999 (copy enclosed) from the Florida Department of State, indicating the receipt by the Division of Corporations of the Application by Foreign Corporation for Authorization to Transact Business in Florida.

The letter states that DCL's application has been retained due to information from the Florida Department of Revenue indicating that DCL began transacting business in Florida on January 1, 1988. The letter goes on to explain the civil penalties and annual report fees due to the Florida Department of State being \$12,596.25 for the period from January 1, 1988 to the present.

DCL Associates, Inc. is a consulting business. Dean Lovett, the president and sole shareholder of DCL relied on professionals to guide him as to the proper legal and tax filings for DCL during the period of transition of DCL's operations from state to state. He was not made aware of the requirement to register DCL with the State of Florida upon the commencement of business there.

Immediately upon receipt of the enclosed letter explaining the requirements for registration, steps were taken to register DCL Associates, Inc. and receive the authorization to do business in Florida. DCL first began transacting business in Florida on January 1, 1994. Business operations were transferred to Maryland in 1995 and back to Florida from 1996 to the present. There was no intentional disregard for the law on the part of DCL or it's shareholder and we therefore request on their behalf that the civil penalties be abated for the years of non-qualification and that the Florida Department of
