Dear Mr. Rivers:

We are writing to you on behalf of our client, Coffee America (USA) Corporation in connection with the attached letter dated May 4, 1999 which states that penalties have been assessed because the corporation conducted business in the State of Florida prior to qualification.

We request that the penalty be abated based on the following explanation. In the years prior to qualification the Company had different owners, outside accountants and lawyers whom they relied on to provide them with all the required Florida filings. Since Florida Forms F-1120 were filed for all years, the new owners believed that the Company was properly registered with the State. As soon as the Company was notified of the unintentional error, arrangements were made to properly register with the Florida Secretary of State. We feel that the new owners should not be held accountable for the sins of the former owners.

Therefore on behalf of the Company, we request that you accept the above explanation as reasonable cause and abate the penalties charged.


