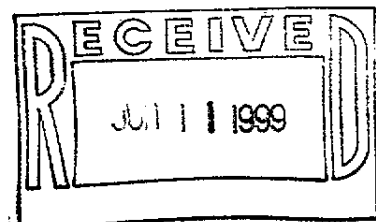

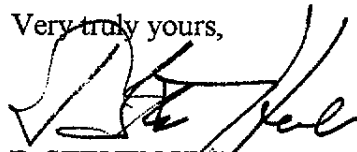

2. I am the Secretary of Comprehensive Assessment Services, Inc., an Ohio corporation (hereinafter referred to as the "Corporation").

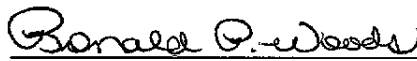

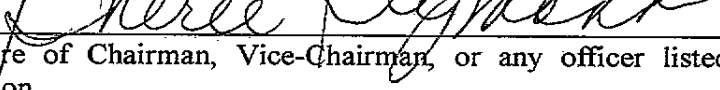
