This letter is in response to your letter of May 6, 1999, regarding failure to apply to qualify to conduct business in Florida which requested payment of an annual report and penalty fees in the amount of \$ 3,465.00.

Duratex North America, Inc. began filing corporate income tax returns in Florida after beginning to make sales in Florida during the year ended 12/31/96. We have continued to file returns and pay any tax due in a timely manner. We were unaware that we were required to file the Application by Foreign Corporation for Authorization to Transact Business in Florida.
