I am in receipt of your letter, dated June 17, 1999, regarding United Group Service Centers' Application by Foreign Corporation for Authorization to Transact Business in Florida. There seems to be some confusion as to whether United Group Service Centers, Inc. (UGSC) is required to be licensed with the Florida Department of State.

Although UGSC has been in business since April 3, 1989, the company has never conducted the type of business in the state of Florida which would require the company to be registered with the Department of State. 
