On March 15, 1999 I received a letter from Agnes Lunt, Document Specialist advising that my corporation owed the State of Florida Eleven Thousand Five Hundred Sixty One Dollars and Twenty Five Cents (\$11,561.25) due to business conducted in the State of Florida prior to filing an "Application for Authority to Transact Business in Florida".






