

SECOND RESTATED ARTICLES OF INCORPORATION

The Corporation hereby restates these articles of incorporation pursuant to Section 33-10-107 of the South Carolina Code Annotated.

- 1. The name of the proposed corporation pursuant to these Restated Articles is Telsouth Communications, Inc. The former name of the corporation, as contained in the corporation's previously Restated Articles of Incorporation was Resort Hospitality Services, Inc.
- 2. The date of filing of the original Articles of Incorporation of the corporation was September 14, 1993, and the Articles of Incorporation were restated on August 30, 2000.
- 3. The Articles of Incorporation are hereby amended to reflect the change of corporate name specified in Paragraph One of these Restated Articles.
- 4. The registered office of the corporation pursuant to these Restated Articles is 78-B Arrow Road, Hilton Head Island, South Carolina 29928.
- The registered agent of the corporation continues to be Nickey B. Maxey.
- 6. The corporation is authorized to issue a single class of shares, and the total number of shares authorized is 100,000.
- 7. The transfer of shares are subject to the restrictions set out in Sections 33-18-110 through 33-18-130 of the 1976 South Carolina Code, as amended.
- The Company operates without a board of directors.
- 9. The Company has not included optional provisions in the articles of incorporation.
