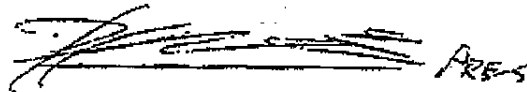

1. The name of the Corporation is CACTUS ENTERPRISES I, INC. (the "Corporation"), bearing Document Number F99000004164.
2. The Corporation was incorporated under the laws of the State of Delaware.
3. The Corporation was authorized to transact business in Florida on August 12, 1999.
4.
