

(Under Section 805 of the New York Business Corporation Law)

FIRST: (the "Corporation")

The name of the corporation is WILLIAM F. COSULICH ASSOCIATES, P.C.

SECOND: The Certificate of Incorporation of the Corporation was filed with the Department of State on June 24, 1976.

FOURTH: The Amendment to the Certificate of Incorporation was authorized by the unanimous vote of the board of directors followed by the unanimous written consent of the holders of all outstanding shares.
