Dear Mr. York:

I represent a small family-owned business by the name of Souvenir City of Perdido Key, Inc., a small souvenir and gift shop on the outskirts of Pensacola along Perdido Key near the border with Alabama. Back in 1990 this company purchased business licenses, received tax identification numbers, and began selling souvenirs, shells, and other items to the tourists that drove along the beach road. Each year since its inception it has filed tax returns, filed employees' taxes, purchased business licenses, and did every other act it thought it was supposed to do in order to pay its fair share of its tax responsibilities. A few years after going into business it was sold to the current stockholders who are the daughter and son-in-law of the original owner. At no time in the past has it ever been sued, nor has it ever been cited for failure to abide by any state law, regulation, or other mandatory requirement of law. In fact, until it received a letter dated June 8, 1999, from the Florida Department of State, a copy attached, no one had any idea that the business had not complied with all of the rules or regulations. I pulled the original file in my office to determine what, if any, activity had taken place with this small family-run business as I had not heard from them in many years, and discovered that the last notation in my file was from 1992. The failure to file qualifications to do business was inadvertent at best and never designed to attempt to circumvent any obligation of the corporation in any way. A quick perusal of the tax and other records required to be filed in Escambia County, Florida, or with the State of Florida will reveal that in all respects this small family-run business has never failed to file any documents, pay any tax, or do any other thing requested or required by the State.

My client is requesting a remittiture of the penalty fees in full with the caveat that all back reporting fees must be paid, and appropriate documents requesting qualification to

do business within the State being filed. I have enclosed copies of the forms requesting the State of Florida to allow this small company to qualify to do business in the State, as well as certificate in good standing with the State of Alabama from its Secretary of State, and this request for remittiture of the penalty. It seems to me the purpose of civil penalties is to punish those who, for whatever reasons, choose to attempt to circumvent the laws of a particular state or governmental entity, usually for personal gain, without regard to the responsibilities inherent of such businesses to the communities in which they operate. That is not the case here, nor has it ever been. Souvenir City of Perdido Key has employed and paid Florida residents to work, paid all fees, expenses, and taxes when requested or required when they were known to be paid, has not conducted its business in a manner to clog up the Florida courts with pointless/useless or frivolous litigation and is only requesting the remittiture of the civil penalty because the purpose for the penalty and the remedial action for which it is imposed is inappropriate in this instance. Your consideration to this matter would be greatly appreciated especially in light of the State's demand for this huge sum of money to this small business.
