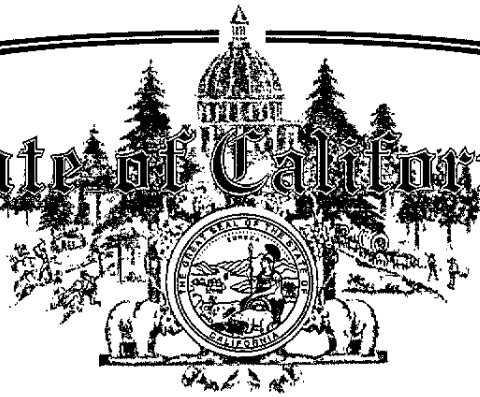

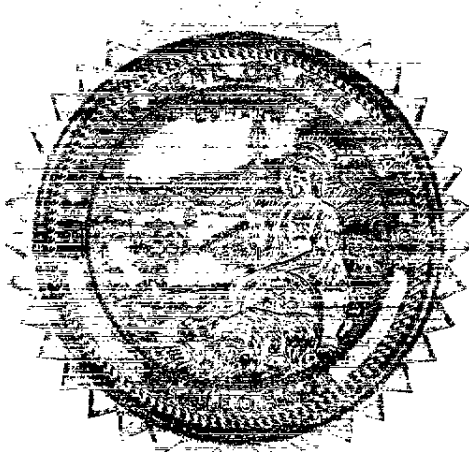
That said corporation's corporate powers, rights and privileges are not suspended on the records of this office; and
