purposes.



To Whom It May Concern:

We just received notice of revocation of our SUN Symphony Society. We have always been extremely careful to respond to whatever was required, so your abrupt notification came as a shock.

Last April we sent you a check for \$61.25 together with the UBR. I personally took it to the post office directly from our accountant's office, and mailed it immediately to your office. Our Secretary Treasurer accompanied me to our accountant, Stuart Wardlaw, and witnessed me mailing it. Somehow it must have got lost in the postal system since apparently never reached you. Or perhaps it became lost in your system.

We are a tiny but growing organization with very little money yet with upcoming substantial outreach projects which seek to improve the cultural and educational life of the entire community here in South Florida, in particular the children and young people. We plead with you not to dissolve SUN. We can't afford to pay for reinstatement and will also lose at least one contribution by the interim loss of our ability to offer a tax write-off to the contributor. So please accept the enclosed check for \$61.25 as replacement so we can continue in business.
