**Purpose Clause of  
GRP Realty Corp.**

Notwithstanding any other provision of the Certificate of Incorporation or the By-Laws of the Corporation, the limited purpose of the Corporation is to (a) subject to Sections 3, 5, 7(c), 8, 9, 13, 14 and 15 herein and that certain Loan and Security Agreement by and among German American Capital Corporation ("Lender"), GRP Loan Corp. and GRP Realty Holdings Corp. (the "Loan Agreement"), acquire by capital contribution from GRP Realty Holdings Corp., hold, manage, operate and sell certain foreclosed properties (the "Foreclosed Properties"), (b) distribute proceeds from the sale of the Foreclosed Properties to GRP Realty Holdings Corp. and (c) engage in any and all lawful business for which a corporation may be organized under the Act that is incident, necessary and appropriate to accomplish the foregoing. The Corporation shall not incur any indebtedness that is outside the ordinary course of its business or that is not related to the ownership and operation of the Foreclosed Properties.
