

Pursuant to Section 607.1109 of the Florida Business Corporation Act ("BCA")

SEVENTH: The merger shall become effective as of November 29, 1999.

EIGHTH: These Articles of Merger comply and were executed in accordance with the laws of each party's applicable jurisdiction.

AGREEMENT AND PLAN OF MERGER

OF

PENSACOLA NEWS-JOURNAL INC.

INTO

MULTIMEDIA CABLEVISION, INC.

The following Agreement and Plan of Merger was adopted and approved by each party to the merger in accordance with Section 607.1107 of the Florida Corporation Act and Section 33-11-101 of the South Carolina Business Corporation Act:

FIRST: The exact name and jurisdiction of each merging party is as follows:

A. The manner and basis of converting the interests, shares, obligations or other securities of each merged party into the interests, shares, obligations or other securities of the survivor, in whole or in part, into cash or other property are as follows:

Each share of outstanding capital stock of Pensacola News-Journal Inc. shall be canceled without any consideration therefor or conversion thereof. The articles of incorporation of the surviving corporation shall be the articles of incorporation of Multimedia Cablevision, Inc. on the effective date of the merger. The authorized capital stock of Multimedia Cablevision, Inc. and the ownership thereof shall not be effected by the merger. The outstanding shares of capital stock of Pensacola News-Journal Inc. are held by Gannett Co., Inc. The outstanding shares of capital stock of Multimedia Cablevision, Inc. are held by Multimedia, Inc.

B. The manner and basis of converting rights to acquire interests, shares, obligations or other securities of each merged party into rights to acquire interests, shares, obligations or other securities of the surviving entity, in whole or in part, into cash or other property are as follows:
