**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
ADVANCED DATA SOLUTIONS, INC.,
a Georgia corporation**

The undersigned, J. Alan Whorton, President of ADVANCED DATA SOLUTIONS, INC., a Georgia corporation (the "Corporation"), organized and existing under and by virtue of the Georgia Business Corporation Code, does hereby certify:

1. The name of the Corporation is ADVANCED DATA SOLUTIONS, INC.
2. The following provision of the Articles of Incorporation of the Corporation is amended in the following particular:

Article I is deleted and replaced with the following:

FIRST: The name of the Corporation is MedAdmin Solutions, Inc. (the "Corporation").

3. In accordance with Section 14-2-1006(4) of the Georgia Business Corporation Code, this Amendment shall be effective upon its filing with the Georgia Secretary of State.
4. The foregoing Amendment was adopted on January 22, 2001, by written consent of the Corporation's shareholders pursuant to Section 14-2-1003 of the Georgia Business Corporation Code. The number of votes cast by the shareholders for the amendment was sufficient for approval by the shareholders.

In accordance with Section 14-2-1006.1(a)(b) of the Georgia Business Corporation Code and following the filing of the Articles of Amendment with the Georgia Secretary of State, a "Notice of Change of Corporate Name" will be published in a newspaper in Cobb County, located in 1000 Circle 75 Parkway, Suite 480, Atlanta, Georgia 30339.
6. Except as modified hereby, the Articles of Incorporation of the Corporation shall remain in full force and effect.
