

Notwithstanding any other provision of this Application By Foreign Not For Profit Corporation For Authorization To Conduct Its Affairs In Florida, the Corporation is organized exclusively for charitable purposes and intends at all times to qualify and remain qualified as exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as it may be amended (the "Code").




