I, FERNANDO ENRIQUE ALVARADO RAMIREZ, Official Translator of the Ministry of Foreign Affairs and Cult of the Republic of Costa Rica, appointed by Accord No 74 of January, 1992, published in La Gaceta Nº 71 of April 10, 1992, certify that in English the photostatic copy document to be translated reads as follows: Jose Enrique Porras Thames, Notary Public with office in San Jose. Certifies: Witnessed at Public Registry that in page two hundred and forty-nine of Book one thousand two hundred twenty-three of the Mercantile Section, appears Entry number two hundred seven which corresponds to coporation named D Saji Internacional Sociedad Anonima, judicial identity card number three-one hundred one-two five three four seven four. As conforming to previously mentioned entry, the domicile of said corporation located in the city of San Jose, Rohrmoser, from Clinica Loretto, one hundred meters south and two hundred east, without affecting to have agencies or branches in any place within the country or abroad. Capital stock is represented by twelve one-thousand-colones shares, dully underwritten and paid thus: six shares mister Dennis Sanchez Fonseca, of age, married once, economist, domiciled in San Jose, identity card number one-two hundred forty-seven-zero eighty-three, and six shares mister Jose Elias Jimenez Vega, of age, married once, accountant, domiciled in Santo Domingo de Heredia, identity card number one-four hundred seventy-four-one hundred forty-nine; the social term is one hundred years starting on the fifth day of October of the current year, the object of the corporation is industry, cattle raising, agriculture, tourism, and commerce in general, representation of foreign and national firms, importing and exporting of all kinds of goods and any other related businesses of any sort. It can become part of other corporations, as well as sell, rent, own, and dispose of or receive any kind of goods or real estate, property or personal rights, valuable titles or similar and dispose of or encumber same as per its needs and in general, to perform any kind of actions or agreements for the exploitation of the corporation (enterprise). The social businesses are managed by a Board of Directors or Management Council formed by three members, partners or not, whom will hold office for the entire legal term, whom are not elected by cumulative votes, holding the



shareholders assembly the right to revoke the appointments at any moment and elect other members who are: President, Secretary and Treasurer. The President and the Secretary shall have the legal representation of the corporation, acting jointly or separately, both with general powers without amount limitation as per number one thousand two hundred fiftythree of the Civil Code, who can issue all kinds of powers to members of the Board of Directors, shareholders or other persons, including those necessary for the operation of bank accounts, revoke the granted powers, substitute them totally or partially without losing the original powers. The legal representation is held by messrs. Dennis Sanchez Fonseca, of above mentioned qualifications, and Alicia Jimenez Vargas, of age, married once, a housewife, domiciled in San Jose, identity card number six-one hundred twenty-one-four hundred seventy-one, whom hold the positions as president and secretary to said corporation, respectively, current terms. For what is stated in entry two of article four hundred thirty-eight of the Civil Proceeds Code, I hereby certify that the certified inscriptions are not modified nor cancelled by any other entry. That is all. I issue this certification as per the request of mister Dennis Sanchez Fonseca, of qualifications mentioned above, any omission can not alter or modified the certified, in the city of San Jose, at ten hours of this twenty-eighth day of October of nineteen ninety-nine.
