

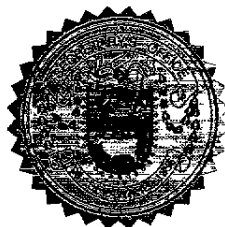

FIRST: The following provisions of the Articles of Incorporation of the Corporation be and they hereby are amended in the following particulars:


Article First be and it hereby is amended to read as follows:
