
COMMENTS: This communication is pursuant to our conversation today regarding annual report fees and statutory penalties assessed against Bavaria Enterprises, Inc. ("Bavaria") under section 607.1502(4), Florida Statutes.

Bavaria has filed an Application for a Certificate of Authority indicating it has transacted business in Florida since 1996. If this is correct, then an amount of \$3465 in penalties and annual report fees is now due. 
