The form I am sending you is the 1<sup>st</sup> UBR form I received.



I signed up with the state of Florida mid Dec. 1999, with the understanding (I thought) that I would not be transacting business until Jan. 2000. I just wanted to have the paper work in order by the time of opening.

I did explain, to the first agent I spoke with in Dec. 1999, that I was not going to open business until Jan. of 2000, and was under the presumption that the year 2000 would be considered our first year of business.
