We, the undersigned, of full age, being desirous of associating ourselves together for the purposes as hereinafter more particulary described, pursuant to and in conformity with the Religious Corporation Law of the State of New York.

FIRST: That the particular objects for which the said corporation is formed are as follows, viz:

To establish and maintain a congregation and/or synagogue for the purpose of conducting Jewish worship in any building, meeting room, auditorium or other meeting place which the said corporation shall either rent, hire, lease, purchase or hereafter construct and build.

CERTIFICATE OF AMENDMENT

of

Pursuant to Article 10 of the Religious Corporation Law.

FIRST: That the name of this Corporation is and henceforth shall be CONGREGATION BETH ELISHAMA DAVID INC., the name under which it was originally formed, having been BETH RUTH TEACHERS SEMINARY OF AMERICA.

SECOND: Its Certificate of Incorporation was filed with the County Clerk of Kings County on February 21, 1978.

THIRD: That the changes to the Certificate of

Incorporation effected by this Certificate is as follows: 22

(a) To change the name of said comporation, BETH RUTH TEACHERS SEMINARY OF AMERICA, under which ham the Corporation was formed, to CONGREGATION BETH ELISHAMA DAVID INC.

(b) To add two paragraphs to the Certificate, so as to make the Corporation eligible for tax exemption privileges under the Internal Revenue Code, as follows:

Notwithstanding any other provision of these articles, the corporation is organized exclusively for one or more of the following purposes: religious, charitable, scientific, testing for public safety, literary, or educational

purposes, or to foster national or international amateur sports competition (but only if no part of its activities involve the provision of athletic facilities or equipment), or for the prevention of cruelty to children or animals, as specified in section 501(c)(3) of the Internal Revenue Code of 1954, and shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue of 1954.

In the event of dissolution, all of the remaining assets and property of the corporation shall after necessary expenses thereof be distributed to such organizations as shall be qualify under section 501(c)(3) of the Internal Revenue 2. Code of 1954, as amended, or, to another organization toobe used in such manner as in the judgment of a Justice of the Supreme Court of the State of New York will best accomplish the general purposes for which this corporation was formed.

FOURTH: That these changes were authorized by a two-thirds vote of all members qualified and entitled to vote thereon.
