

ARTICLES OF INCORPORATION

The undersigned certifies that:

- 1. He is the Chief Financial Officer, Executive Vice President and Secretary of Draper's Rossmoor, Inc., a California corporation.
- The Articles of Incorporation of this corporation are amended and restated 2. to read as follows:

I.

The purpose of this corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Law of California other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the California Corporations Code.

This corporation is authorized to issue only one class of shares; and the total number of shares which this corporation is authorized to issue is ten thousand (10,000).
