Enclosed please find our check for \$165.00 for our annual filing fee. We are well aware that we are past the deadline of May 1 and that the current filing fee is now \$550.00.

Please consider the following in your decision to waive the past due penalty.

- 1. Our business of 22 years is in serious demise; having operated at a loss in recent years.
- 2. We have continued to hope and pursue the business with loans, credit cards, etc. and have recently decided that "band-aids' will not fix it anymore.
- 3. On June 20, 1997 we laid off two key employees in order to reduce overhead, a very painful decision in a small shop where it's a family.
- 4. We have recently gone through a 5 year sales tax audit, that was extremely time consuming and the end result has presented us with a proposed assessment that is significantly over stated and will require serious hours of analyzation to prove audit errors.
- 5. Our current(6/97) accounts payables are \$52M, our current receivables are \$42M, we have loans in the amount of \$30,000 and our current equity is \$24,000.
- 6. None of the above looks very good...but We don't believe in the easy out option of Chapter 7, 11 or whatever, We don't believe in the bankruptcy option. If we bought something from someone, they'll get paid!

Our sincere request is that you will consider our current circumstances and accept our filing fee of \$165.00, forgiving the late penalty

If not, we will be forced to close our corporation status and function as a sole proprietorship under a fictitious name, which we would prefer not to decide.
