Dissolution was approved by the shareholders and the number cast for dissolution was sufficient for approval.

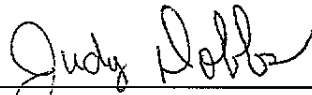

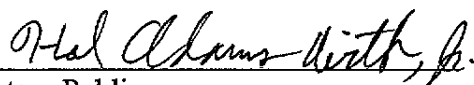
