Pursuant to Section 607.1105 of the Florida Business Corporation Act, the undersigned corporations adopt the following Articles of Merger:

- The plan of merger is as follows: 1.
 - TBU, Inc. ("TBU"), a Florida corporation, will be merged with and into U.S. Propane, Inc. ("USPI"), a Florida corporation, and USPI will be the surviving corporation. (a)
 - All of the outstanding shares of common stock of USPI and all of the outstanding (b) shares of Griffis, Inc., a Florida corporation wholly-owned by the same sole shareholder of USPI, will be converted into an aggregate of 606,060 shares of common stock of TECO Energy, Inc, a Florida corporation that owns 100% of the issued and outstanding stock of TBU.
 - Each share of common stock of TBU shall be converted into and become one share of (c) common stock of the surviving corporation.
- The effective date of the merger is the date of filing of these Articles of Merger. 2.
- The Agreement and Plan of Merger dated as of January 20, 1998, pursuant to which TBU will 3. be merged with and into USPI was adopted by the sole shareholder of TBU on January 20, 1998, and by the sole shareholder of USPI on January 19, 1998.

IN WITNESS WHEREOF, these Articles of Merger have been executed on behalf of U.S. Propane, Inc. and TBU, Inc. by their respective authorized officers as of the 37th day of January, 1998.
