AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF

KURT SCHMIDT ENTERPRISES, INC.

In compliance with the requirements of F.S. 607.0602, the Florida Profit Corporation Act, the following amended and restated articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is KURT SCHMIDT ENTERPRISES, INC.

ARTICLE II

The street and mailing address of the principal office of the Corporation is 730 Highline Drive, Panama City, FL 32404 and P.O. Box 10037, Panama City, FL 32404.

ARTICLE III

The maximum number of shares this Corporation is authorized to issue is 400, par value \$1.00 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

The initial board of directors shall consist of two members. This number may be increased or decreased from time to time in accordance with the Corporation's bylaws, but shall never be less than one.

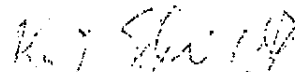
ARTICLE VII
