Pursuant to the provisions of Section 607.1006 of the Florida Business

Corporation Act, the undersigned corporation adopts the following Articles of

Amendments to its Articles of Incorporation:

- 1. The name of the corporation is M. & G. SIGN PRODUCTS, INC.
- 2. The following amendments of the Articles of Incorporation were adopted by the shareholders of the corporation on MAY / 2 , 1999, in the manner prescribed by the Florida Business Corporation Act:

ARTICLE I. NAME

The name of the corporation is hereby changed from M. & G. SIGN PRODUCTS, INC. to M&G SIGNS, INC.

- 3. The number of shares of the Capital Common Stock of the corporation outstanding at the time of adoption was 7500, and the number of shares entitled to vote thereon was 500. The shareholders unanimously approved this amendment to articles herein.
