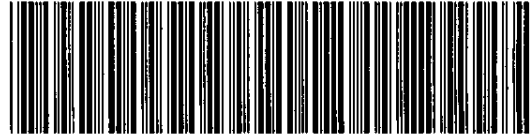

PURSUANT TO SECTION 607.1006 OF THE
FLORIDA BUSINESS CORPORATION ACT

1. The name of the Corporation is LYKES LAND INVESTMENTS, INC.

NAME

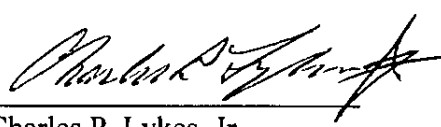
The name of this corporation is Lykes Lane, Inc."
