I have just received my corporation's annual report packet, and discovered to my dismay that this is a "2nd Notice", which bears a whopping \$400 late-fee. Actually, the basic fee is confiscatory, stripping me of all profits during these, the Corporation's product-development years.....and the \$400 late-fee would frankly put the corporation out-of-business.

Unable to believe the State's purpose is to squash promising business undertakings, I placed a call to your office. I was told to submit the filing together with \$150, and my circumstances would be reviewed for justification of a late-fee waiver. The Filing is enclosed, and this letter is my appeal.

As you will notice in the report, the business address has changed. (I have retired from my other career, to give more time and attention to this corporation.) Although I have been appalled, ever since the monstrous filing-fee increase a few years back, that the State is permitted to impose a business-tax in excess of the business' profits, I have dutifully complied every year on a timely basis. My tardiness this year was not deliberate.....in fact it comes as a total surprise to me.

Please accept my filing with the standard \$150 payment. If you are unable to do this, please return my check.
