Gentlepersons:

I have just received notification that my corporate filing was not made on a timely basis, and that I have incurred a \$400 late fee. This came as a total, shocking surprise to me, as I had carefully calendared the filing for late April, near the deadline because the confiscatory filing fee quite frankly must come from my personal funds. The corporation is in its product-development stage, and the fee totally wipes out any proceeds from business operations.

A check of my calendar revealed that on April 23, the date I had scheduled the filing, I was out-of-town performing in a (free) concert at Windermere, Fla. That still doesn't explain to my own satisfaction just how I could overlook the calendar entry.....but overlook it I obviously did.

Unwilling to believe it is the State of Florida's intention to force promising enterprises out of business, I am enclosing my check for the regular \$150 fee, and am appealing for waiver of the late fee.

Although I cannot understand the reasoning behind, or the justification for confiscating more than 100% of a small business' profits, I have paid the fee every year and had provided for its timely payment this year. It's tardy submission is the result of a regrettable personal oversight, and I am requesting that you waive the monstrous \$400 penalty, which is so disproportionately large, and would effectively put me out of business.

Please accept my filing with the standard \$150 payment. If you are unable to do this, please return my check.
