Gentlemen:

This letter is to set forth the reason for not having timely filed the Uniform Business Report for the year 2002.

Our corporation was at 1398 Fourth Street, Daytona Beach, Florida 32124 in 2001 and filed its UBR on January 2001.

Two months later, the corporation moved its place of business to its present address of 307 Carswell Avenue, Holly Hill, Florida 32117. The U. S. Postal Service was notified of the change of address so all correspondence and notices would be properly delivered to the latter address. At the same time, the corporation sent a notice of "change of address" to the Division.

It appears that the notice was not received at the Division and that for some unknown reason the Division's notice for the filing of the 2002 UBR was not delivered to the corporation's latest address.
