Dear Sir or Madam:

My name is James Angelo Pappas. After I organized J.A. Pappas Electric, Inc., at 135 ½ Highland Road, Rt. 2, Box 715, Tarpon Springs FL 33589, the County of Pinellas, State of Florida, and the United States Postal Service reorganized our Highland Road with new house numbers and a new Zip Code (Mid-1984, if my memory serves me well).

The corporation number issued by the State of Florida was (and is still---) G08970. The FEI number issued by the IRS was (and is still---) 592259810. This happened on 11/10/83, based upon the 135 1/2 Highland Road address.

I happily went on with business affairs, timely filing Corporation IRS forms, assuming that everything was "A-OK," until I got notice (4/2/03) from the Florida Worker's Compensation Compliance's Audrey Jackson (850-488-2333, X165) that my application for an exemption for worker's compensation was denied because of my business was "INACTIVE with the Florida Division of Corporations (FDOC).

After talking with Barbara Mitchell @ FDOC and telling her about the "glitch" in the mailing address that government created for our Road here in Tarpon Springs---never receiving any info/forms/inquiries/assessments from Tallahassee via the USPS---she worked up a total reinstatement fee of \$2167.50 and asked me to write a cover letter about the address problem created by government.

Thanks to Barbara Mitchell, I now understand how the availability of the internet website (sunbiz.org) enables me to track the progress of my FL Corporation now, and in the future.
