ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
ACME SPONGE & CHAMOIS CO., INC.

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, ACME SPONGE & CHAMOIS CO., INC., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

The Articles of Incorporation for the Corporation were filed on November 30, 1982 and assigned Florida Document Number G09925.

ARTICLE I
Name

The name of the Corporation is ACME SPONGE & CHAMOIS CO., INC.

ARTICLE II
Amendment

This Amendment changes the name of the Corporation to THE ACME SPONGE COMPANY and, therefore, the old Article I of the Corporation's Articles of Incorporation is hereby deleted and the new Article I is added and shall read as follows:

The name of the Corporation is THE ACME SPONGE COMPANY."

ARTICLE III
Date and Manner of Adoption
