ARTICLES OF AMENDMENT

1. The following provisions of the Articles of Incorporation of LUSK, DRASITES, & TOLISANO, P.A., a Florida corporation Tallahassee, Florida, on NOVEMBER 30, 1982, be and they hereby ASSEE, FLORIDA amended in the following particulars:

Article III(a) be and it hereby is amended to read as follows:

The total number of authorized shares of the capital stock of this corporation is 1,800 shares of common stock at one dollar (\$1.00) par value per share, divided into two classes: 600 shares of voting common stock and 1,200 shares of non-voting common stock.
