The purpose of this correspondence is to respectfully request abatement of the additional \$400.00 in filing fee for the annual corporate report. To impose this fee would create an extreme hardship for this small business.

Until two years ago, I was an active and full-time owner of this small business. Due to financial circumstances and health issues of my husband, I was forced to seek full-time employment in another city. I kept the business in the event I might be able to return and placed a manager in position. The manager left for another position at the end of 1998 and I have operated the business with clerical staff.

When the annual report came in the mail, the receptionist placed the report in a corporate tax file and it was never brought to my attention. What should have happened is that the report should have been placed in the accounts payable file to be review and a check disbursement made.

I was unaware that the report had not been filed when I received this second notice several weeks ago. I have been to August, GA at the medical college for treatment for my husband three times since July and was not able to address the issue until now.

I called the Department today. The staff person was very kind and asked me to send in the check for \$150.00 with a letter of explanation. I hope you will note that this firm has always been prompt in filing of the annual report and the issue did not get addressed due to the above-described circumstances.
