ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
SULZER OSCOR INC.

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, Sulzer Oscor Inc., a Florida profit corporation (the "Corporation") adopts the following articles of amendment to its articles of incorporation:

FIRST: Article I of the Corporation's Articles of Incorporation is hereby deleted and the following is substituted in lieu thereof:

"ARTICLE I

The name of this corporation is OSCOR INC."

SECOND: This amendment shall be effective as of the date such amendment is filed with the Department of State of the State of Florida.

THIRD: The amendment was approved by the sole shareholder of the Corporation on February 17th 1999, pursuant to § 607.0821 of the Business Organizations Law of the State of Florida.

FOURTH: The amendment was approved by the board of directors of the Corporation on February 17th 1999, pursuant to § 607.0704 of the Business Organizations Law of the State of Florida.
