

SECOND: This amendment shall be effective as of the date such amendment is filed with the Department of State of the State of Florida.

THIRD: The amendment was approved by the sole shareholder of the Corporation on February 17th1999, pursuant to § 607.0821 of the Business Organizations Law of the State of Florida.

FOURTH: The amendment was approved by the board of directors of the Corporation on February 17th 1999, pursuant to § 607.0704 of the Business Organizations Law of the State of Florida.
