1. The Articles of Incorporation of Schroeder and Smith, Professional Association, were filed in Tallahassee, Florida on December 3, 1982. Articles of Amendment amending the name to GEORGE S. SMITH, III, C.P.A., P.A. were filed on May 10, 1994. Article I of the Articles of Amendment to Articles of Incorporation of GEORGE S. SMITH, III, C.P.A., P.A., is hereby further amended to read as follows:

ARTICLE I  
NAME

The name of this corporation shall be Cohen, Smith & Company, P.A. and the address of the corporation shall be 133 East Indiana Avenue, DeLand Florida 32724.


