DATE OF AMENDMENT'S ADOPTION

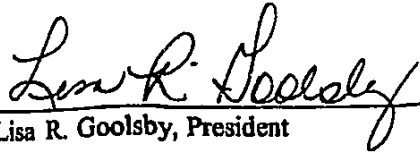
This Amendment adoption shall be adopted and effective as of June 21, 1996.
