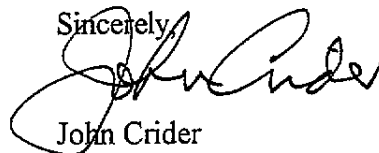

**ARTICLES OF AMENDMENT OF
ARTICLES OF INCORPORATION OF
CRIDER LAW FIRM, P.A.**
