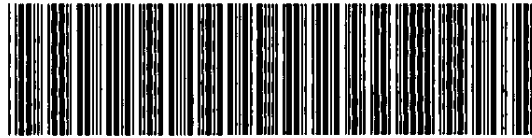

SECOND: The following amendments to the Articles of Incorporation were adopted by the corporation: The amendment was adopted by the shareholders on March 23, 2010.


Article I: The name of the corporation shall be CASSIDY & ASSOCIATES OF WINTER HAVEN, INC. ("corporation").
