ARTICLES OF DISSOLUTION  
THE CHARTERED LAW OFFICES OF BENJAMIN K. PHIPPS

In accordance with Section 607.1403, Florida Statutes, these Articles of Dissolution are filed with the Department of State:

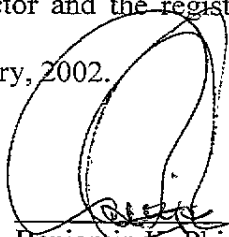
(a) The name of this corporation is The Chartered Law Offices of Benjamin K. Phipps, a corporation registered under Chapter 607, Florida Statutes, with the Florida Department of State. The corporation is a law office incorporated as a professional service corporation, under Chapter 626.

(b) At a meeting of the sole shareholder/director, held on 31 December 2001, all of the assets, liabilities, net worth, and all other rights, entitlements, and obligations of the corporation were transferred to the newly formed and registered *The Chartered Law Offices of Benjamin K. Phipps, LLC*, and this corporation was ordered dissolved.

(c) The vote to dissolve was unanimous.

(d) The corporation had only two shareholders, the corporation and Benjamin K. Phipps. All shares voted to approve the actions described in (b) above.
