Pursuant to the provisions of Section 607.181 of the Florida General Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is TELEPHONETICS INTERNATIONAL, INC.

2. The following amendment to the Articles of Incorporation was adopted by the Board of Directors of the Corporation on February 3, 1999.

ARTICLE I is amended to read as follows:

The name of the Corporation shall be: EIGHTEEN ENTERPRISES CORPORATION.
